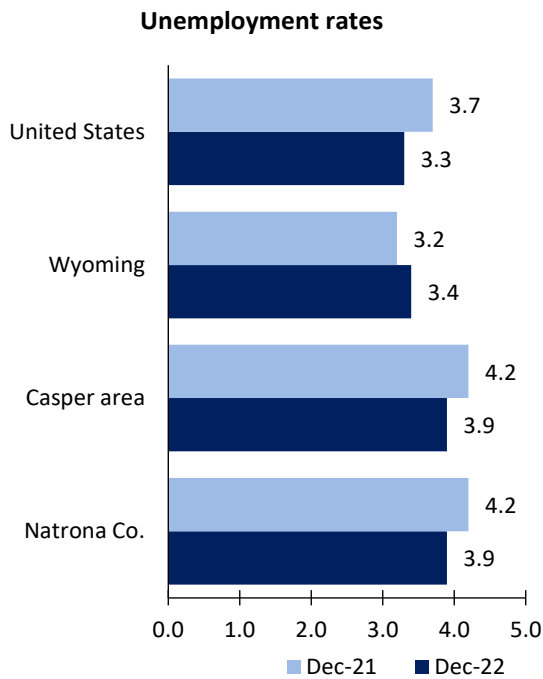


Casper Area Economic Summary

Casper area, second quarter 2022

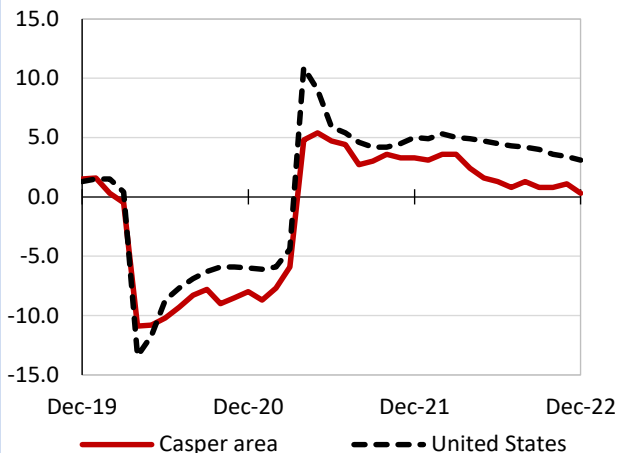

12-month percent changes in employment



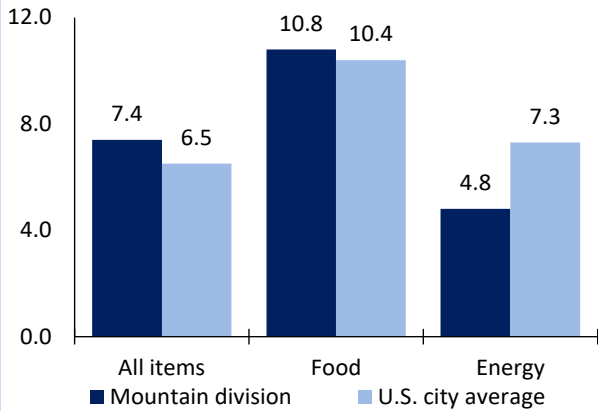

Over-the-year change in the prices paid by urban consumers for selected categories

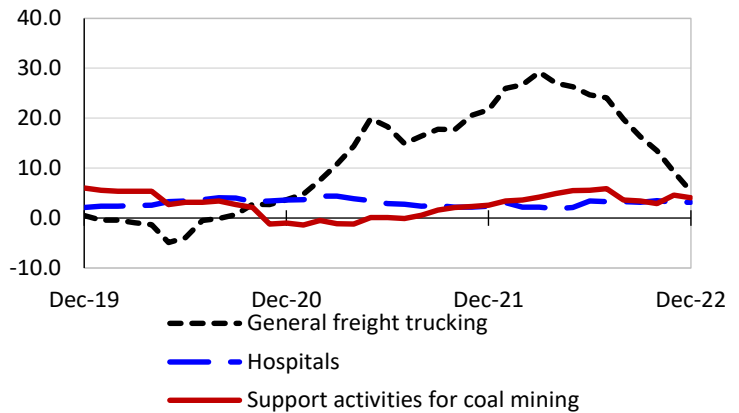
12-month percent change in CPI-U, December 2022

Over-the-year changes in the selling prices received by producers for selected industries nationwide

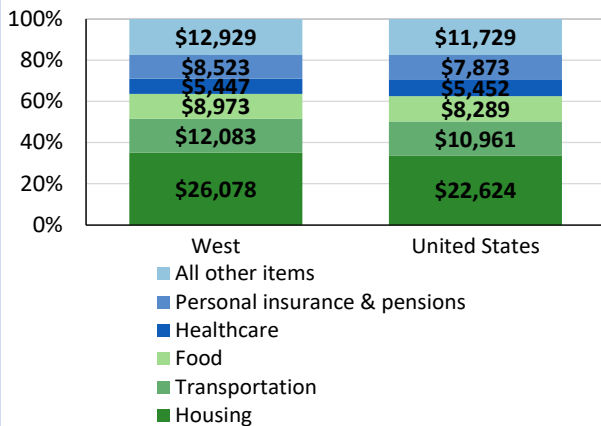
12-month percent changes in PPI

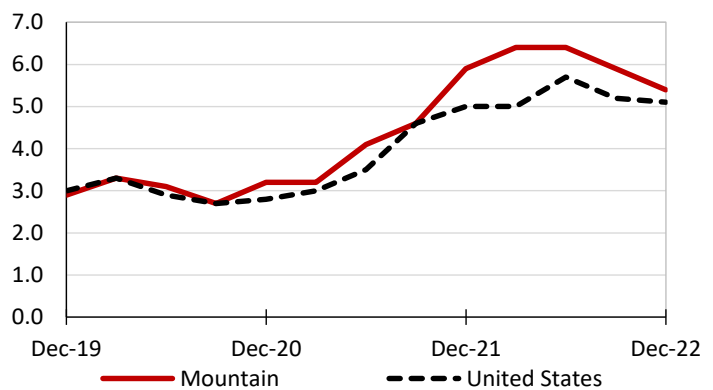
